The Planning Council meeting was called to order at 9:05 a.m. by 1st Vice Chair Larry Cook, with a request for a moment of silence for those we have lost to HIV/AIDS.

A motion was made, and seconded and passed to adopt the January 19th Planning Council agenda.

Consumer Caucus: Phyllis Malone - The Consumer Caucus met on Wednesday, January 18th at 1237 Ralph David Abernathy. The next meeting will be held on Wednesday, February 15th from 12:00 p.m. - 2:00 p.m. at SisterLove Motherhouse located at 1237 Ralph David Abernathy. The Caucus has scheduled their evening meetings to be held from 6:00 p.m. - 8:00 p.m. on the fourth Thursday, of each quarter.

AAOI Update: Heremyone Wilson - AAOI will be held on February 18th & 19th, 2012 at the Loudermilk Center. AAOI registration was extended until Tuesday, January 31st and already 303 individuals have registered, with 22 children for childcare. The next annual AAOI fundraiser "Jazz for a Cause" will be held on Thursday, January 26th at Acoustix Jazz Restaurant & Lounge located at 840 Marietta Street Atlanta with a special performance by Alex Bugnon. Community Planning Group: Larry Cook - The Community Planning Group met Tuesday, November 14th & Wednesday, November 15th in Savannah to recap previous meetings. The next Community Planning Group meeting will be held Monday, February 20th & Tuesday, February 21st in Atlanta.

Grantee Update: Kandace Carty - The Request for Proposal was released on Monday, January 9th with a deadline date of Friday, March 9th. The Grantee's office held a Community Outreach Workshop on Monday, January 9th with six (6) agencies in attendance. There will be two mandatory Technical Assistance Workshops held at the Atlanta – Fulton Public Library – Mechanicsville Branch on Tuesday, January 24th for Currently Funded Agencies (9:00 AM to 12:00 PM) & Wednesday, January 25th for Not Currently Funded Agencies (9:00 AM to 5:00 PM)

The Outside Review Committee met Friday, December 16th at the Loudermilk Center to allocate the additional Supplemental funding the EMA received (\$1,943,189). Fourteen (14) applications were received from Currently Funded Applications totaling \$1,468,568, leaving a remaining balance of \$474,620. After the applications were reviewed, the Committee approved \$1,299,114 in requests, leaving a remaining balance of \$644,074. The Grantee noted that in addition there could be additional Administrative and/or Planning Council Funds bringing the total of FY 2011 unawarded funds to approximately \$700,000.

Priorities Committee: Jeffrey Mitchell - *Action Item*- The Priorities Committee met on Wednesday, January 11th at the Fulton County Government Center to discuss the allocation of unawarded funds. The Grantee provided an update on the recent ORC process, the availability of unawarded funds, and a recommendation that the Priorities Committee reconsider one of their previously approved funding scenarios regarding ADAP and/or HCIP. Mr. William Lyons and Ms. Libby Brown from the Georgia Department of Public Health presented a proposal to offset ADAP expenses.

Discussion:

The Planning Council raised some concern about the remaining funds being allocated to the State ADAP program and why the State is currently accepting or is need of the additional dollars. The Council was then informed that as of January 5, 2012, there are 1,287 clients on the ADAP waiting list, with 67% enrolled within the EMA sites. The additional funds would provide services for 749 Grady clients at the cost of \$700,315 (\$677,845 medications + \$22,470 dispensing/ administrative fee) The Grantee

explained that the funds would not be given to State, but to Grady for 749 of their clients on the ADAP waiting list. In addition, it would allow 64 persons to be removed from the waiting list. The Planning Council also questioned if other options were considered to expend the unawarded amount. Ms. Carty informed the Council there is not enough time for the Grantee's office to do another RFP and have another ORC process and implement contracts before the end of the fiscal year.

A motion was made, seconded and carried to use any remaining and unawarded funds at the end of the FY11 year for the State ADAP Program. Yes: 29 No: 2

Comprehensive Plan Update: Katherine Lovell – The Metropolitan Atlanta HIV Health Services Planning Council 2012 – 2014 Comprehensive Plan is ready for review. The draft of the plan will be available on the Grantee's website at http://www.co.fulton.ga.us/ryan-white-home and available for commenting from Friday, January 20th - Thursday, February 2nd all comments should be sent to RWhiteProjects@fultoncountyga.gov. The Planning Council will vote at the March 15th meeting on whether to approve the plan, prior to submittal to HRSA in May.
