The Planning Council meeting was called to order at 9:08 a.m. by, Chair Dazon Dixon Diallo.

A motion was made, seconded and passed to adopt the revised January 17th Planning Council agenda.

AAOI Update: Hermeyone Wilson – AAOI will be held on Friday & Saturday February 8th & 9th, 2013 at the Loudermilk Center. The annual AAOI fundraiser "Jazz for a Cause" "will be held on Thursday, January 24th at Acoustix Jazz Restaurant & Lounge located at 840 Marietta Street in Atlanta. Grantee Update: Kandace Carty - Staff attended the "All Grantee's Meeting" in D.C. during the month of November. The meeting was informative, but did not provide the anticipated insight relative to the Affordable Care Act and its impact on the Ryan White Program. Staff has received notice that the FY13 HRSA award will be given in partial allotments. The Notice of Grant award for fifty percent (50%) of the FY 2012 Formula award and 50% of the FY 2012 MAI award will be forwarded by March 1st and the remaining award will be sent at a later date. The Grantee's office received approval for the carryover request of \$238,000 in FY 2011 funds which the Planning Council approved to be split 50/50 between the Primary Care and Oral Health priority categories. Staff developed a mini Request-for-Proposal that was sent out to currently funded agencies. Seven (7) applied and five (5) applicants received funding. All of the primary care funds were awarded, but approximately \$48,000 in oral health care remains unawarded at this time.

The FY 2013 Request for Proposal was released on Tuesday, January 8, 2013. A Technical Assistance Workshop was held for interested parties at the Grantee's Office. There will be two (2) mandatory Technical Assistance Workshops held at Fulton County Health and Human Services Building located at 137 Peachtree Street on Wednesday, January 23rd for currently funded agencies & Thursday, January 24th for agencies not currently funded. The meeting time is 9:00 a.m. – 5:00 p.m. for both workshops. The Outside Review Committee (ORC) Phase I will be held on March 27th – 28th and Phase II on Wednesday & Thursday, April 3rd – 4th at the Loudermilk Center.

Consumer Caucus: William Francis - The Consumer Caucus met Wednesday, January 16th at SisterLove located at 1237 Ralph David Abernathy Blvd. There were 19 consumers in attendance. The Caucus voted to meet regularly at AID Atlanta located at 1605 Peachtree Street. The Caucus also reviewed its By-Laws, Standard Operating Procedures and discussed using Skype as another way for consumers to participate in meetings when ill. It was also announced that evening meetings will resume in March. The Caucus voted and appointed Tony Redmon as Vice Chair, Michael Robinson as Secretary and James Lark as Parliamentarian.

A motion was made, seconded and, after brief discussion, passed to extend the Planning Council meeting to 10:50 a.m.

Budget Revision(s): *Action Item*- Uliecia Bolton: Budget revision requests were received to move \$56,289 from Oral Health to Primary Care, \$2,475 from Substance Abuse to Support Services, \$36,045.51 from Mental Health to Primary Care, \$139,370.21 from AIDS Pharmaceutical Assistance Program to Primary Care, \$26,500.00 from Case Management to Primary Care and \$4,000 from Substance to Primary Care. **(See Attachment).**

Discussion

Several members of the Planning Council expressed concern regarding the proposed budget revisions, specifically, about moving funds out of the Oral Health category given the need and priority ranking of this service. The Council was reminded that agencies have to provide a thorough justification for their proposed request. Funds were being moved into Primary Care to address shortages in personnel and lab costs. The Council was informed that if the proposed budget revisions are not approved, it is possible that the money will not be spent and will be returned to HRSA, which could result in penalties against next year's funding.

William Francis requested that, in the future, all action items be presented to the Consumer Caucus prior to the Planning Council meeting.

Membership Committee: Antoinette Barnes – New Member Orientation was held on Friday, December 16th at the Loudermilk Center with 40 individuals in attendance. It was noted that most Committee Chairs participated in the Orientation.

Public Policy: Jeff Graham- There are 6,520 individuals on ADAP, 317 on the Pre-Existing Condition Insurance Plan (PCIP), and 355 on the Healthcare Insurance Continuation Program. On Tuesday, February 19th Georgia Equality is partnering with Cover Georgia for Citizen Advocacy Day at the Capitol. On Thursday, February 28th from 6:00 p.m. - 8:00 p.m. at the Phillip Rush Center. Georgia Equality will partner with Georgians for a Healthy Feature to facilitate training on how the Medicaid system in Georgia currently works and why expansion is a crucial issue; approximately \$3.5 million will be needed if Medicaid is not expanded to support people currently enrolled in PCIP after it expires later this year.
